Local Member - Php150.00/per head

Overseas Member - US\$15.00 / per head

Lifetime Members - Exempted from Membership Dues


Payments can be made at the International Headquarters or deposited through Metrobank (Port Area, Branch) S/A number 151-3-15151380-9 or Bank of the Philippine Islands, (Intramuros Branch) U.S. Dollar Account No. 4954-0143-18, SWIFT CODE: BOPIPHMM.

For administrative control purposes and based on the rules, only members and chapters in good standing can vote and be voted upon on May 30, 2010. All chapters/members in good standing will be posted.

Sec 2 of Article VI. (Election of Executive Officers) of the *Amended By-Laws of the KOR* states that "Only members in good standing shall be entitled to any vote on any matter requiring votes or be voted upon for any office or position in the Order." The 2008 Omnibus Rules and Regulations Governing the Conduct of the Election of the Members of the SC in Section 603 defines a knight in good standing as one "who has paid all his membership dues, authorized assessments and other valid charges, plus applicable charges owing thereon...and Section 702 defines a chapter in good standing as one "which has paid all registration fees, chapter remittances, authorized assessments and other valid charges and applicable charges owing thereon."

May we also request all KOR chapters to submit their reports of activities and list of paid members as we prepare the Rizalian Year Report 2008-2010 hopefully for distribution during the General Assembly.
